The book describes our feelings of frustration, anger and stress, until an attorney named Sid Suo came into our lives. He gave us hope and confidence, believed in us and gave us the will to beat this false charge. *Guilty Until Proven Innocent* lists the things you should and shouldn't do if you find yourself in police custody. For example, do you know your Miranda rights? Last but not least, *Guilty Until Proven Innocent* describes a promise made, and a promise kept.
